2. Approve Minutes of June 29, 2014

Minutes were approved with no changes.

3. Treasurer's Report (Ramadoss)

- The General account has a balance of \$9,481.
- The Scholastic Reserve account has a balance of \$8,395.
- Payments for the *Rank & File* magazine and the Memorial Day Classic scholastic tournament trophies (\$200) have not yet been made.
